

# GDPR INFORMATION CLAUSE

## INFORMATION DEDICATED TO BUSINESS ENTITIES WHOSE PERSONAL DATA IS COLLECTED ON THE BASIS OF INFORMATION GATHERED IN PUBLICLY AVAILABLE DATABASES OF ENTREPRENEURS

The legal basis for the information provided is Article 14.1 – 14.2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter “GDPR”).

### PURPOSES OF PERSONAL DATA PROCESSING AND LEGAL BASIS FOR PROCESSING

Your personal data will be processed by the Administrator for the following purposes:

- Article 6(1)(f) GDPR, i.e. for the purpose of building a database on Polish and foreign entrepreneurs (activities related to collecting and storing databases of personal data from publicly available registers),
- Article 6(1)(b) of the GDPR, i.e. for the purpose of providing comprehensive economic information within the framework of the databases offered and created (the activity of creating databases of information at the request of clients and their further provision in the legitimate interest on the basis of concluded service contracts),
- Article 6(1)(f) of the GDPR, i.e. for purposes arising from our other legitimate interests, including the assertion of legitimate claims.

### INFORMATION ON RECIPIENTS OF PERSONAL DATA OR CATEGORIES OF RECIPIENTS

Your personal data is processed by the Administrator and by entities cooperating with the Administrator for the purpose of fulfilling the Administrator's legal obligations or legitimate interests. The basis for the processing of personal data by other entities is a separately concluded agreement on the entrustment of personal data processing.

We indicate that we may entrust your personal data to entities with which we cooperate in the following areas:

- entities for which we prepare databases of information, which may contain personal data from publicly available databases of information (CEIDG, KRS),
- entities with whom we cooperate within the framework of IT services, including providers of IT platforms that we use in connection with our business,
- other entities whose services we use to fulfill our obligations under the law.

### SOURCE OF PERSONAL DATA

In addition to data obtained directly from you, I may also process other data. For this purpose, I may use publicly available sources (Central Business Activity Register, National Court Register, other publicly available databases of information about entrepreneurs).

#### CATEGORIES OF RELEVANT PERSONAL DATA

The Administrator will process personal data to the extent necessary to fulfill the purpose for which the data are collected.

#### TRANSFER OF PERSONAL DATA TO THIRD COUNTRIES (OUTSIDE THE EU/EOG AREA)

Your personal data may be transferred to third countries, i.e. outside the European Union and the European Economic Area.

I would like to inform you that in each of these situations, appropriate mechanisms for the transfer of personal data based on the decision of the European Commission guaranteeing the security of personal data processing in a specific country or with the observance of the so-called standard contractual clauses, binding corporate rules or other legal instruments aimed at maintaining the GDPR standards applied by us are always applied.

#### DURATION OF PROCESSING OF YOUR PERSONAL DATA

Your personal data will be kept for the period necessary to fulfill the purposes for which they are processed by the Administrator.

#### YOUR RIGHTS

You have the right to:

- 1) gain access to your data,
- 2) request rectification or deletion of your data,
- 3) limit the processing of your data,
- 4) transfer of your data,
- 5) the right to object to the processed data.

In order to fulfill their request, you should contact the Administrator at our contact address.

In certain situations, strictly defined by law, the Administrator may refuse to carry out a specific request.

#### THE RIGHT TO LODGE A COMPLAINT WITH A SUPERVISORY AUTHORITY
