# PURPOSES OF PERSONAL DATA PROCESSING AND LEGAL BASIS OF PROCESSING

The personal data provided by you will be processed by the Administrator on the basis of:

- Article 6(1)(f) of the GDPR in order to pursue its legitimate interest in carrying out e-mail correspondence with you, including answering your questions and providing you with information.

#### TRANSFER OF PERSONAL DATA TO THIRD COUNTRIES (OUTSIDE THE EU/EU)

Your personal data may be transferred to third countries. i.e. outside the European Union and the European Economic Area.

I would like to inform you that in each of these situations, appropriate mechanisms for the transfer of personal data are always applied based on a decision of the European Commission guaranteeing the security of the processing of personal data in a specific country or with the observance of so-called standard contractual clauses, binding corporate rules or other legal instruments aimed at maintaining the RODO standards applied by us.

#### **DURATION OF PROCESSING OF YOUR PERSONAL DATA**

You are entitled to file a complaint with the President of the Office for Personal Data Protection if you believe that our actions are inconsistent with this policy. However, I encourage you to contact the Administrator in advance to clarify any concerns.

The provision of data is not a statutory requirement, but is necessary in order to conduct e-mail correspondence with you.
